Motion to ratify the reinvestment of Sewage Surcharge Funds in two PLGIT Certificate of Deposit accounts as follows: \$178,697.12, 90-day account at 4.30% yield and \$247,000.00, 90-day account at 4.70% yield with maturity dates of August 18, 2025.
