# Meeting Minutes

**Date:** January 6, 2025, 10:00am

**Location:** Terry's office

**Subject:** Status and Coordination of Activities with Implementing the City Ordinance for the Registration and Inspection of Vacant and Abandoned Properties

**Attendees:** Terry Carcella, Dan Weimer, Jarod Trunzo, Linda McKenna, Steve Gifford, Tracy Legato, Joshua Mayro, Andy Maheny, Ralph Jenko

- The Chiropractor's office on Ligonier Street has been approved for demolition by the County Commissioners. Demolition is expected to occur in April.
- Jarod suggested that a review of the County Property Assessment Task Force needs to occur. The assessment was done in 2021. While the County has not agreed to do the reassessment for us, we need to get the criteria they used for ranking properties (red/yellow/green) and understand their methodology. While not an immediate task it should be considered for later in the year.
- Dan and Josh provided a status update on Smart Gov. It is not 'live' yet and still undergoing validation. Permitting is ready to 'go live' and reports are being built. While 'go live' is expected soon, no date was established.
- Vacant Property Registration. Currently working on a list of 47 properties, all but 3 are blighted. It was suggested that before we utilize efforts to expand the list, we first develop and prove out the processes for registering and inspecting these properties. A registered letter (to be developed with Legal?) will be sent to the property owner. If no response in 30 days, an additional letter will be sent every 30 days. After three letters, the plan is to take it to the Magistrate.
- Steve has created paper and fillable PDF forms for property owners to register their properties and included a list of items that are

recommended to be inspected when properties are registered. They are attached to the email.

- Tracy has all properties in Smart Gov to issue Storm Water fee notices. She does monthly updates with the County Property Deed report to reflect new property owners.
- Complaints continue to be a major activity within Code Enforcement. There is currently no back log, with all complaints quickly acted upon.
- The old Flower Shop property on Lincoln across from LES has multiple (6?) citations going back to 2022 for overgrown/weeds. It is ready to take to the magistrate.
- It is difficult to access and retrieve Code QC (Quality of Community) tickets issued prior to 2023. They were filed in paper by owner name, not property tax number, and stuffed into file drawers. A history of evidence of citations is important for the Magistrate to act appropriately.
- The group agreed that the current priorities are to focus on the initial list of vacant/abandoned properties, send out notices, and target zones within the City, not individuals.
- Jarod requested that we include the Business district when dealing with abandoned/vacant properties. The old Manos Theater needs to be added. Jarod has forwarded the Magistrate's ruling for the Theater on back taxes (attached). They must be paid in full by July 31, 2025, else the property will go up for sale. This may offer an opportunity to remediate this property. If conservatorship is to be considered, it must be done prior to the property being listed for sale.
- Jarod requested that the City assist with identifying potential residential properties as candidates for the 2025 NAP project and to forward that information to Steve for vetting. Since there are income requirements for participation, Terry will ask Berkheimer for a report of employee taxes to help identify potential candidates.
- Terry updated the status of 1701 Jefferson St. An active sewer line is running through the property that is not on any utility map. This complication may require rerouting prior to sale of the property.
- The LERTA ordinance approved by the City is still pending final approvals. The School Board needs to approve it prior to final approval

by the County. Need a meeting with the interim school board superintendent to encourage approval. Jarod and Steve to follow up.

- Jarod has provided a copy of the 2021 Blight Study and a copy of the independent 2013 study on Sweeny properties.
- Going forward with the Vacant/Abandoned Property Registration program, there was discussion on getting marketing experience to assist with the communications. Terry is to review potential St. Vincent interns with marketing interests.

At the conclusion of the meeting, everyone agreed it was time well spent. The next meeting is scheduled for Feb 12, 9:30, in Terry's office.

**Advisory Reviews of Subdivisions, Land Developments, Zoning Ordinances,  
Comprehensive Plans, and Other Actions**

Please be advised that this letter serves as an annual reminder to Westmoreland County municipalities regarding advisory reviews of subdivisions, land developments, zoning ordinances, comprehensive plans, and other related actions.

In addition to proposed subdivisions and land developments, municipalities are also required to forward proposed zoning ordinances, comprehensive plans, and other actions to the Westmoreland County Department of Planning and Development for advisory review before taking action on the matter. See below for more information.

1. **Effect of a County Comprehensive Plan.** When Westmoreland County adopted a comprehensive plan in 2005 and has since updated it in 2018, §304 of the PA Municipalities Planning Code (MPC) became effective. MPC §304 requires municipalities to forward certain proposed actions to the county planning agency for an advisory review, including the following:
  - a. the location, opening, vacation, extension, widening, narrowing or enlargement of any street, public ground, pierhead or watercourse;
  - b. the location, erection, demolition, removal or sale of any public structures located within the municipality;
  - c. the adoption, amendment or repeal of any comprehensive plan, official map, subdivision or land development ordinance, zoning ordinance or provisions for planned residential development; or
  - d. the construction, extension or abandonment of any water line, sewer line or sewage treatment facility.
2. **County Review Period: 45 Days.** Since MPC §304 is applicable in Westmoreland County, the county review time is 45 days for proposed actions. MPC §304(b) states that municipalities may not take any action until the county's comments are received, or the 45-day review period has passed.
3. **County Review Period: 30 Days.** MPC §502(b) states that municipalities may not approve a proposed subdivision or land development until the county's comments are received, or the 30-day review period has passed.
4. **Failure to Comply.** If a municipality does not follow the applicable procedures of the MPC when amending or adopting zoning ordinances and comprehensive plans, or taking other actions authorized by the MPC, it can leave the municipality vulnerable to challenges. Municipalities should always be careful to comply with the MPC, and consider consulting their solicitor if they have questions about the required procedures.

This job required that I be able to safely build and operate JLG equipment such as boom lift, scissor lift, fork lift, sky track and much more heavy equipment had to learn to build all machines from frame to finish troubleshooting issues along the way
