Thank you again for expressing your interest in the Whole Home Repair Program! If you are receiving this message, please know that we still have your contact information and your description of the repairs needed at your home.

We're reaching out to you to share some important information about the program.

Action Housing has announced that the Whole Home Repair Program application will accepted electronically. The application will open on May 30th and remain open until June 30th.

At this time you have only sent in an interest form, <u>not</u> an application for the program. In order to submit an application, you'll need to do so *electronically* at this website:

There is very high demand for this program. The funding currently available will not be adequate to assist everyone who is qualified and submits an application. Action Housing will be working with experts to prioritize applicants based on the severity of need. You are encouraged to apply as early as possible once the application opens on May 30th.

To assist with application submissions the following documents should be brought with you:

- o Proof of homeownership
- Proof that your total income doesn't exceed 80% of the Area Median Income.
 Acceptable proof includes but isn't limited to:
 - IRS Form 1040 for the 2022 Tax Year
 - W-2 Form for the 2022 Tax Year
 - Pay Stubs
 - Letter from your employer with pay rate and hours worked
 - An Award letter from the Social Security Administration, Veterans Administration, PA Dept of Labor and Industry, PA Dept of Human Services, or other government agencies that show recurring income from any public benefit program.
 - Award letters for pension or retirement benefits.
