Proclamation



WHEREAS: Herbert William Kavash, World War II veteran and constant supporter of all things North Wales Borough, died on November 30, 2024.

WHEREAS: Herb was born November 17, 1925 in the neighboring Borough of Lansdale and while life took him as far as Africa, the Middle East and South America, he was never far from his roots.

WHEREAS: Herb graduated from Lansdale High School in 1943; joined the United States Navy's V-12 Officer Training Program which sent him to Princeton University, Cornell University and others and he had the opportunity to be friend Albert Einstein.

WHEREAS: Herb was assigned to the U.S.S. Bonhomme Richard, an aircraft carrier hunting German U-Boats and served as a human computer, making sure aviators were able to accomplish their missions and return home safely; Thanks to his work, his team never lost an aircraft.

WHEREAS: Herb met Molly Maag after he was discharged from active duty, the story of "Molly and Herb" started when they married in 1949 and remained so for 62 years where Molly participated in Borough government and regional politics and Herb volunteered in our community.

WHEREAS: Herb was a committed volunteer – serving as a fire police officer and Treasurer for the North Penn Volunteer Fire Company – along with numerous other service organizations; Herb also served on the Board of the North Wales Water Authority from 2006 to 2017.

WHEREAS: Herb also served the St. Peters Evangelical Lutheran Church as caretaker of its cemeteries and columbarium, mapping out the graves and placing flags on graves for Memorial Day and Veterans Day.

WHEREAS: The community spirit of "Molly and Herb" continues today, with daughter Councilmember Sally Neiderhiser's service on Council and through his children, Connie, Betsy, Kate, 4 grandchildren and 3 great-grandchildren.

WHEREAS: Small communities like North Wales Borough exist and thrive because of the commitment of people like Herbert Kavash to step up for the purpose of making a genuine difference in the Borough;

NOW THEREFORE, I, Neil McDevitt, Mayor of the Borough of North Wales, Pennsylvania, do hereby proclaim January 18, 2025, to be Herbert W. Kavash Day in North Wales Borough. I encourage all citizens to support their local communities in Herb's example with selfless service to others and making their communities a better place.

Proclamation



WHEREAS: The Holocaust was the state-sponsored, systematic persecution and murder of an estimated 17 million people by the German Nazi regime, under the leadership of Adolf Hitler, between 1933 and 1945.

WHEREAS: German Nazis not only targeted the European Jewish population, but countless others, including Romani, individuals with disabilities, homosexuals, Poles, Communists, Soviet citizens, Socialists and Jehovah's Witnesses, due to perceived racial and biological inferiority and on political, ideological and behavioral grounds.

WHEREAS: On January 27, 1945, Soviet soldiers opened the gates to Auschwitz-Birkenau, the largest and deadliest concentration camp, and liberated more than 6,000 prisoners, most of whom were ill and dying due to the horrors they were subjected to by their captors.

WHEREAS: In 2005, in commemoration of the importance and significance of that event, the General Assembly of the United Nations adopted a resolution establishing January 27 as "International Holocaust Remembrance Day".

WHEREAS: January 27 serves as both a day on which the lives of those who perished during the Holocaust are honored and on which a commitment to human rights is reasserted by rejecting any denial of the Holocaust as a historical event and educating new generations of the atrocities that transpired in an effort to prevent future acts of genocide from occurring.

WHEREAS: The General Assembly of the United Nations also encourages, as part of its original declaration in 2005, that this day be used to condemn all manifestations of religious intolerance, incitement, harassment or violence against individuals or communities based on ethnic origin or religious belief, whenever they occur.

NOW THEREFORE, I, Neil McDevitt, Mayor of the Borough of North Wales, Pennsylvania, do hereby proclaim January 27, 2025 as International Holocaust Remembrance Day in the Borough of North Wales in memory of the victims of the Holocaust, and in honor of the survivors, as well as the rescuers and liberators, and further proclaim that we, as residents of Conshohocken Borough should strive to overcome intolerance and indifference through learning and remembrance.
