Levy County Canvassing Board Minutes
Recount for Town Commission, Certify Election Results
April 28, 2026, Town of Inglis Special Election
May 1, 2026, 9 a.m.

The Levy County Canvassing Board convened at 9:01 a.m. on May 1, 2026. Present were Canvassing Board members Tammy Jones, Michele Langford, and Desiree Mills, along with Supervisor of Elections staff members Jordan Lindsey and Jennifer Mathews.

In the absence of Judge Bustamante, Desiree Mills made a motion to appoint Tammy Jones as Chair. The motion was seconded by Michele Langford and approved unanimously.

Desiree Jerrels moved to approve the minutes from the April 28, 2026 meeting. The motion was seconded by Tammy Jones. Michele Langford then moved to approve the minutes from the April 30, 2026 meeting, which was seconded by Tammy Jones. Both sets of minutes were approved unanimously.

The Board discussed procedures for conducting a machine recount. Test ballots were run through two tabulation machines to confirm proper operation. Upon verification and sign-off, each machine was reset to zero.

Official ballots were retrieved from sealed ballot containers and processed through their respective tabulation machines. The machine recount totals were compared to the election night results and found to be identical. The Canvassing Board then filed a second set of unofficial results.

Desiree Mills made a motion to proceed with a manual recount. The motion was seconded by Michele Langford and approved unanimously. Ballots reflecting an undervote were set aside and reviewed to determine voter intent. No changes to the vote totals were identified. The Canvassing Board subsequently certified the election results for the 2026 Town of Inglis Special Election.

The Voting Systems Post-Election Audit Report was signed by all. Since the election required a manual review, Florida Statutes 102.166 does not require the audit.

With all business concluded, Tammy Jones moved to adjourn the meeting at 10:28 a.m. The motion was seconded by Desiree Mills and approved.
