Please let me know the next steps in the process if you still need a backfill for this position.



Member McClure made a motion to Approve the July 8th Meeting Minutes. Member Neiderhiser seconded the motion. Motion passed 5 yes, 0 no.

Old Business / Committee & Board Reports / Zoning Applications / Parking Lot

No Old Business or Committee and Board reports. Manager Hart made an update pertaining to the most recent zoning hearings; 405 School Street was awarded the variances they requested, and 501 W. Walnut Street received relief from all the items on their application, except for two: height and density (number of units). To date, nothing further has been submitted from the applicant.

Parking Lot is put on hold until more review can be performed, and more Council members are present to discuss.

Solicitor Gifford announced that there will be an executive session after the meeting to discuss a personnel matter but does not anticipate any action being taken. No Mayor's report.

Member McClure announced that the Parks and Recreation Board will be meeting with a Bird Town representative at their next meeting and asked that Council come and support the project.

Member Whelan thanked the North Wales Area Library for the incredible programs offered throughout the summer months, especially for children.

Vice President Tarlecki updated everyone that the Sensory Wall at the elementary school is close to completion. He recommends that everyone see it. He also announced that there seems to be a small herd of deer within the Borough, and to be aware of the deer droppings on properties.

Manager Hart gave an update on Public Works, explaining that the summer part-time employee, Connor Paulus, went back to school. Joseph O'Mara has recently joined the team, as has Thomas Hartman, who has returned as a seasonal employee.

Member McClure asked the Chief about the new cell phone law. The Chief responded that they have made a few stops and that for the first year, people will receive a warning.

Manager Hart updated Council on Parks and Recreation Board's Scavenger Hunt, North Wales Area Library's Walk and Track initiative, and the After-school Art Club offered at Borough Hall.



Findings of Fact: The Secretary of the Interior's guidelines recommend:
Designing enclosures for historic porches when required by
the new use in a manner that preserves the historic character
(design) of the building. This can include using large sheets of
glass and recessing the enclosure wall behind existing
scrollwork, posts and balustrades.

Note to Council – The building in question is in the historic
district and although not technically “historic”, it was
faithfully designed (approx.. 25 years ago) to model a late
19th/early 20th century style (Homestead style). It is an

archetype for residential infill. As a result, we have relaxed the strict requirements of the "guidelines" by recommending the reinstallation of the balustrade in a position that allows the overall design to be evident without requiring the removal of the recently installed enclosure. The applicants seem pleased with the compromise.

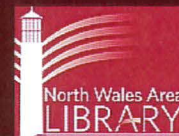
