2025 CATTARAUGUS MARKET INFORMATION

Accessing Parking and Vendor Sites: Parking will be available at the vendor site or across from the market lot. 10'x10' vendor sites will be assigned upon arrival. Please arrive between the hours of 1:00pm and 2:30pm. Do not arrive any later than 2:30pm. If you require more than 2 hours to set up, contact Rebecca Ellis (716-560-8772) for accommodations.

We ask vendors to remain in their assigned space for the duration of the event. One vendor per site or registration. Vendors may request additional sites. Vendors will be able to pull up to unload their vehicles.

Farm Animals (Livestock) and Pets: With the exception of service animals, vendor-owned livestock and/or pets are NOT allowed on the event property. In addition, the sale of live or unprocessed animal carcasses is NOT allowed at the market.

Restrooms: A Porta Potty area will be made available on the site for public restrooms.

Refuse/Recycling: Each vendor will be assigned a designated site and shall be responsible for keeping their space free from all refuse during the event. The vendor's space should be kept neat, orderly, and safe.

Each vendor MUST clean and remove all material, litter, and debris from their area within 30 minutes after the close of the event. All refuse shall be deposited in the on-site garbage receptacles. All vendors are required to protect their area from damage (cooking spills, tent stakes, etc.).

Tobacco: The Village of Cattaraugus and event organizers are requesting that vendors, and visitors, refrain from using tobacco products, including vape pens, at their sites for the duration of the event.

Prohibited Sales: There are some items that CAN NOT be sold at this event, at the discretion of market management.

Licenses, Registrations, and Permits: It is the responsibility of the vendor to display all necessary licenses, registrations, and permits from New York State inspectors, Cattaraugus County inspectors, Village of Cattaraugus personnel, and consumers as applicable.
