**REGULAR MEETING MINUTES
YANKEETOWN TOWN COUNCIL
MARCH 2, 2026, At 6:00 PM**

The Regular Meeting of the Yankeetown Town Council was called to order by Mayor Lawrence Vorisek at 6:00 p.m. on March 2, 2026, at Yankeetown Town Hall, 6241 Harmony Lane, Yankeetown, Florida.

Mayor Vorisek welcomed 35 members of the public in attendance and requested that all cell phones be silenced.

The Pledge of Allegiance was recited.

AGENDA MODIFICATION:

Mayor Vorisek stated that an item regarding Certificates of Deposit (CDs) and Money Market accounts would be added to the agenda for discussion.

ROLL CALL:

Present were Mayor Lawrence Vorisek; Vice Mayor Tim Ecker; Council Members Bob Terrian and Allen Casey; Town Attorney Norm Fugate; and Town Administrator Seante Gyukeri.

APPROVAL OF MINUTES:

Mayor Vorisek presented the prior meeting minutes for approval. Motion was made by Council Member Tim Ecker and seconded by Council Member Allen Casey to approve the minutes as presented. Motion carried 4-0 unanimously.

SAVINACIUS – MONTHLY GRANT REPORT:

Jaison Benoit of Savinacious provided an update on ongoing grant activity. Jaison reported that State approvals have been obtained on several projects, with FEMA approval still pending due to a nationwide backlog estimated at approximately \$15 billion in unapproved funds. He noted that approximately \$5 billion has recently been processed and expressed optimism that approvals will begin moving forward more quickly.

Jaison advised that residents may contact federal representatives to advocate for expedited FEMA approvals.

Jaison reviewed multiple active and upcoming grants, including Hurricane Loss Mitigation, Forestry, Boating Improvement, Economic Development, and CDBG-DR funding. He emphasized that the Town is actively pursuing all available funding opportunities. Jaison further reported that historic review requirements have been triggered for elevation projects, with a proposal received in the amount of \$34,450 for required cultural resource assessments. He stated that this expense is expected to be reimbursable upon FEMA approval.

Discussion followed regarding homeowner participation and associated costs, with acknowledgement that homeowners have verbally agreed to participate pending reimbursement.

RESOLUTION 2026-01 – WATER AVAILABILITY FEE:

Mayor Vorisek presented Resolution 2026-01 establishing a \$20 monthly water availability fee for vacant properties with access to Town water infrastructure.

Discussion was held regarding the definition of vacant parcels and applicability to homesteaded and combined parcels.

Motion was made by Council Member Allen Casey and seconded by Council Member Tim Ecker to approve Resolution 2026-01 as presented. Motion carried 4-0 unanimously.

FLOODPLAIN MANAGEMENT SERVICES:

Discussion was held regarding delays with SafeBuilt in providing required floodplain approvals.

Jaison Benoit presented an option for Savinacius to provide services at a rate of \$185 per hour on an as-needed basis.

Motion was made by Council Member Tim Ecker and seconded by Council Member Bob Terrian to approve the use of Savinacius, Task # 6, for services as needed. Motion carried 4-0 unanimously.

PUBLIC ADJUSTER SERVICES:

Discussion was held regarding issuing a Request for Proposals (RFP) for public adjuster services to evaluate and maximize recovery of insurance claims related to storm damage.

Council provided consensus to proceed with issuing an RFP.

HISTORIC ASSESSMENT CONTRACT:

The Council discussed the proposal for cultural resource assessments archeological survey in the amount of \$34,450.

Town Attorney Norm Fugate advised that approval should be contingent upon receipt of homeowner contributions.

Motion was made by Council Member Tim Ecker and seconded by Council Member Allen Casey to approve the contract contingent upon receipt of homeowner payments. Motion carried 4-0 unanimously.

MAINTENANCE DISCUSSION:

Mayor Vorisek reported that inmate labor assistance has been arranged through the Sheriff's Office to assist with Town maintenance.

Further discussion regarding hiring part-time maintenance staff was tabled pending evaluation of available inmate labor.

CD's AND MONEY MARKET ACCOUNTS:

Council Member Tim Ecker presented findings regarding current CD and money market rates and recommended reallocating funds to improve returns.

Motion was made by Council Member Tim Ecker and seconded by Council Member Allen Casey to transfer approximately \$231,000 from Seacoast Bank to Brannen Bank at a rate of 2.51%.

Motion carried unanimously.

COUNCIL REPORTS:

Mayor Vorisek reports the Town water system was reported to be operating without major issues.

Council Member Allen Casey reported on roadway conditions, identifying multiple potholes on Riverside Drive and other Town roads. Coordination with the County for repairs was discussed.

Council Member Bob Terrian reported on Sheriff's Office and Fire Department activity. The town is still consistently under 10% of total calls. Historic Board will need a Board member when Mindy Brady takes her seat on council.

Vice Mayor Tim Ecker reported on Parks and Recreation Board vacancies and encouraged community participation.

TOWN ADMINISTRATOR REPORT:

Town Administrator Seante Gyukeri presented Animal Control and Code Enforcement updates.

Animal Control reported nine service calls, including dog-at-large responses and successful TNR efforts.

Code Enforcement reported seven new cases and six cases closed with compliance. A violation involving fill dirt on Riverside Drive has been referred to DEP for enforcement.

AREA RESIDENT COMMENTS:

Public comments were received regarding zoning updates, drainage projects, and easement status. It was confirmed that required easements have been completed.

ADJOURNMENT:

Motion to adjourn was made by Council Member Tim Ecker and seconded by Council Member Bob Terrian. Motion carried 4-0 unanimously. The meeting was adjourned at 7:35 pm.

Jones Edmunds is pleased to present this Scope of Services and Fee Estimate for the above-referenced project.

PROJECT BACKGROUND

In November 2003, Jones Edmunds, on behalf of the Town of Yankeetown, completed a Watershed Management Plan (WMP) that identified excess runoff from a natural drainage channel along 64th Street that flooded seven homes, six cabins, two commercial businesses, and several vacant lots. The Town has received a Hazard Mitigation Grant Program (HMGP) grant to conduct a hydraulic and hydrological (H&H) study and survey and prepare design documents for the proposed drainage improvements.

The proposed project includes designing an overflow storm inlet structure along 64th Street to be installed close to the existing drainage channel to accept flood waters at a predetermined elevation and convey the runoff south via a new open drainage swale.

The runoff will be conveyed through new culverts under Harmony Lane and Riverside Drive and discharge into an existing swale, that will be improved, and then flow into the Withlacoochee River. A riprap outfall structure will be installed at the river.

In May 2021, Jones Edmunds began preparing construction plans and permitting for this project, but the project was postponed. At this time, the US Army Corps of Engineers (USACE) permit has expired, and the Southwest Florida Water Management District (SWFWMD) expires on December 9, 2027.

This following Scope of Services describes the tasks required for confirming the project design and flow parameters, updating the design, and reapplying for the expired permits.

SCOPE OF SERVICES

TASK 1 – PROJECT MANAGEMENT AND SITE VISIT

KICKOFF MEETING

Jones Edmunds will conduct a kickoff meeting during which the following items will be discussed:

- Key issues and the Town’s objectives and expectations relating to the project.
- Availability of information that will be used for the design of the project.
- Project schedule.
- Method and frequency of communicating/reporting.
- Project team/client roles.

PROJECT MANAGEMENT

- Provide project administration and management of the project team and subconsultants throughout the project.
- Review ongoing activities with the Town on a regular basis.
- Discuss concerns and challenges with the Town as they arise.
- Provide monthly status updates and invoices.

SITE VISIT

A site visit will be conducted to fully understand the existing conditions and constraints that may impact the design and determine if additional information is required. For this Scope of Services, we assume that the survey, wetland limits, and geotechnical is sufficient. The Florida State Preservation Office provided a letter that states that no effect occurs on historic properties and this Scope assumes that is all that will be required. Jones Edmunds will use the data collected with the original design and modeling services.

DELIVERABLES

- Meeting minutes and status updates.

TASK 2 – DESIGN/CONSTRUCTION DOCUMENTS

The Town has an 80-foot ROW along 64th Street, a 30-foot ROW along Harmony Lane, and a 100-foot ROW along Riverside Drive. Jones Edmunds assumes that no permits or permissions are needed from Levy County for the work along or under these roads. The proposed new swale south of Riverside Drive crosses private property. The Town is responsible for obtaining the easement for the swale from the property owner.

Jones Edmunds will review and update the previously prepared Engineering Design and Construction Documents. A new Engineer of Record is required for this project so additional review is required. The Town will review the submittal and the final Drawings will incorporate comments and revisions from the Town’s review, Jones Edmunds’ internal quality-control review, and any regulatory agency comments and revisions.

The Final Construction Submittal Package will be submitted to the Town and include the following:

- Issued for Construction Drawings.
- Issued for Construction Technical Specifications.
- Updated Engineer’s Opinion of Probable Construction Costs (EOPCC).

DELIVERABLES

- Signed-and-sealed electronic copy (PDF and/or CAD format) of the Construction Drawings.
- Signed-and-sealed electronic copy in PDF format of the Construction Technical Specifications.
- Final EOPCC (PDF format).

TASK 3 – PERMITTING

An SWFWMD Individual Construction Environmental Resource Permit (ERP) has been issued for this project and is valid until December 9, 2027. Jones Edmunds will verify that the final design meets the permit conditions and will apply for a permit modification if required.

The USACE Nationwide Permit expired on March 18, 2022. Jones Edmunds will apply for an extension or new Nationwide Permit if required.

DELIVERABLES

- Permit Applications in PDF format, if needed.

SCHEDULE

Jones Edmunds will begin work on this project on receipt of a signed Task Assignment from the Town. The schedule for this project will be based on an agreement between the Town and Jones Edmunds. Preliminarily, the project tasks are estimated to be completed as follows:

* Permit timelines are highly variable. The schedule includes when materials would be submitted to regulatory agencies.

EXCLUSIONS AND CONDITIONS

The following items are exclusions to this Scope of Services:

- Construction administration services.
- Additional survey and geotechnical needs.

- Local road construction permits.
- Cultural Resource Assessment Survey (if required by SHPO and/or appropriate Tribe).
- Wetland mitigation.
- Survey and permitting for sovereign and submerged lands.
- SWFWMD ERP application fees.
- USACE permit application fees.
- Federal Emergency Management Agency map changes or map revisions.
- Florida Department of Transportation permits.
- Legal descriptions for required easements and/or property acquisition.
- Property and/or easement acquisition.

COMPENSATION

Jones Edmunds will perform the Scope of Services as described in Tasks 1 through 3 for a time and materials not to exceed fee of \$36,190.

Jones Edmunds is pleased to present this Scope of Services and Fee Estimate for the above-referenced project.

PROJECT BACKGROUND

Flooding from Hurricane Irma occurred at the intersection of 67th Street and Riverside Drive impacting 11 properties and blocking access to the Recreational Vehicle (RV) Park on Riverside Drive. The natural grade slopes from north to south to a swale on the south side of Riverside Drive.

The proposed project includes modifying a section of swale on the west side of 67th Street to increase the capacity to collect and convey stormwater runoff and route the swale under Riverside Drive through a new culvert connecting into an existing swale that runs west along Riverside Drive to Hickory Street. The existing swale that runs south along Hickory Street will be upgraded to convey runoff to discharge via a closed storm pipe into the marina through an outlet constructed in a concrete seawall. Although this seawall is part of the private marina, a portion of this seawall appears to be constructed within the Town's right-of-way (ROW).

In May 2021, Jones Edmunds began preparing Construction Drawings and permit applications for this project, but the funding was not available at that time, and the project was postponed. This project is to resume the modeling, design, and permitting efforts on that project.

SCOPE OF SERVICES

This Scope of Services describes the tasks required to conduct the hydrologic and hydraulic (H&H) study, design, and permitting services. The Drawings will be reviewed because a new Engineer of Record is responsible for this project.

TASK 1 – PROJECT MANAGEMENT AND SITE VISIT

KICKOFF MEETING

Jones Edmunds will conduct a kickoff meeting during which the following items will be discussed:

- Key issues and the Town’s objectives and expectations relating to the project.
- Availability of information that will be used for the design of the project.

TASK 2 – H&H UPDATE

Jones Edmunds will provide the following preliminary design services:

- Update the existing Stormwater Management Plan (SWMP) model to incorporate any changes in the design.

DELIVERABLES

- Stormwater report summarizing the H&H study.

TASK 3 – DESIGN/CONSTRUCTION DOCUMENTS

Jones Edmunds will review and update the 75% Engineering Design and Construction Drawings, Draft Technical Specifications, and Design Calculations. A new Engineer of Record is required for this project; therefore, additional review and updating is necessary.

We will arrange for pre-application meetings with the Southwest Florida Water Management District (SWFWMD) and the US Army Corps of Engineers (USACE) to assess permitting requirements and solicit feedback on the project.

The Drawings will consist of General and Civil Drawings and will follow Jones Edmunds' presentation standards. Standard details and notes from the Town or County will be used where applicable.

The Plan Sheets will include but not be limited to:

- Title Sheet.
- General Notes.
- Overall Site Plan.
- Plan and Profile.
- Stormwater Pollution Prevention Plan.
- Civil Design Details.

Jones Edmunds will use the standard Construction Standards Institute (CSI) 16-Division-format Technical Specifications, which will be customized for this project.

The 75% Design Drawings and Technical Specifications will be submitted to the Town for review. A virtual meeting will be held to review the submittal and note any comments from the Town.

DELIVERABLES

Jones Edmunds will deliver the following items in PDF format:

- 75% Design Drawings.
- Engineer's Opinion of Probable Construction Cost (EOPCC).
- Draft Technical Specifications.

FINAL DESIGN

The final Construction Documents will incorporate comments/ revisions from the Town's review of the 75% design submittal, Jones Edmunds' internal QC review, and any regulatory comments/revisions.

The Final Construction Design Submittal Package will be submitted to the Town and include the following:

Summary of Activities

During the reporting period, Animal Control responded to a variety of service requests involving domestic animals, feral cat population management, wildlife intake coordination, and neighborhood complaints. A continued emphasis was placed on humane population control through Trap-Neuter-Return (TNR) programs, public assistance, and community outreach.

Domestic Animal Care

- Provided heartworm treatment assistance for one resident-owned dog. The animal was treated and safely returned to the residence. Two follow-up treatment appointments are scheduled for the upcoming month.

Feral Cat Management (TNR Program)

- Coordinated multiple spay and neuter appointments for feral cats.
- Assisted a low-income resident with six feral cats by arranging services and agreeing to subsidize 50 percent of the cost, contingent upon the resident covering the remaining balance. These services are scheduled for April 7, 2026.
- Additional feral cat appointments were scheduled and completed on March 24, 2026.
- Issued traps to residents participating in TNR efforts to support humane capture and transport.

Shelter Intake Coordination

- Arranged intake of one adult cat and two kittens, with drop-off completed on March 24, 2026.
- Coordinated intake of three orphaned raccoons, ensuring transfer to appropriate care for evaluation and rehabilitation.

Public Assistance and Communication

- Responded to multiple inquiries via phone, text, and email regarding feral cat services, scheduling, and animal intake.
- Provided guidance and scheduling support to residents seeking assistance with animal-related concerns.

Complaint Investigations

- Responded to two separate complaints regarding a neighbor's cat.
- Conducted on-site visits and engaged directly with pet owners to address concerns.
- Encouraged compliance with responsible pet ownership, including proper veterinary care and containment measures.
- Worked toward resolution strategies to maintain community harmony and prevent recurring issues.
