Subject: Police Department Monthly Report

September was a busy month for the Dept in regard to Police Calls for service. On 09-03-2023, The Latrobe Police were dispatched to LAH for a male with a gunshot wound. Detectives and Officers from the Latrobe Police Dept. worked with Westmoreland County Sherif's Department FAU team and with he Westmoreland County Detective Bureau to determine the location of the incident and all involved parties. Within 4 days of the incident, the shooter was identified and charged with Attempted Homicide.

The department hosted a Search and Seizure class presented by The Institute for Law Enforcement Education which was attended by over 50 officers from depts. located throughout Western PA. Officers from within the Latrobe Police Dept. attended specialized training for certifications in Defensive Tactics and Commercial Motor Vehicle Inspection.

The new RMS system training began this month with a go live date of 11-07-2023. All records will be migrated into the new system by 11-07-2023.

Evidence destruction was conducted this month with the assistance of PA Department of Military and Veterans Affairs Counterdrug Joint Task Force out of Fort Indian Town Gap utilizing their mobile incineration unit. The following narcotics and associated paraphernalia were destroyed.

6.2 lbs. of prescription medication

3.4 lbs of Methamphetamine

9.2 lbs of Heroin

72.4 lbs. of Marijuana

May this correspondence confirm that I appeared before Judge Anthony G. Marsili as mandated by an Order of Court for a final status conference regarding the pending tax assessment appeal litigation regarding six (6) parcels owned by the above-referenced entity. You will recall that the Greater Latrobe School District filed a tax assessment appeal seeking an increase to the assessed value based on a 1.5 million dollar purchase price listed in a deed recorded in December 2021. The attorney for Centaur 31, LLC and the attorney representing the Greater Latrobe School District agreed to assign a substantial increase in the assessed value based on the purchase price and a Stipulation of Settlement setting forth the terms will be circulated in the near future.

The Solicitor for the Westmoreland County Tax Assessment Board also appeared at this proceeding and the County has taken a position that this is an appropriate settlement and is going to recommend the same to the Westmoreland County Commissioners at its October, 2023 public meeting. Therefore, I request that you include this docket number and a motion to approve Stipulation of Settlement for the October 10, 2023 voting meeting.
