# From the Manager's Desk...

It is the season that a snow emergency may be declared. As a reminder it shall be unlawful, at any time during the emergency, for any person to park a motor vehicle or to allow that vehicle to remain parked on any Cumberland Township Road or any Cumberland Township right-of-way in such a manner as to impede or obstruct the snow and ice removal efforts of Cumberland Township or to create a hazardous condition. Motor vehicles must be equipped with snow tires or chains. No snow shall be thrown or blown into the streets. We ask any residents who can shovel out fire hydrants and handicapped access ramps in the vicinity of their homes. Based upon snow accumulation Cumberland Township Maintenance Department has or will deploy all available personnel, plows, and contracted services to plow and cinder the fifty miles of roads, streets, and berms in the Township.

Any vehicle parked in violation shall be subject to towing at the owner's expense. The Chief of Police or those operating under his direction shall attempt to contact the owner of the vehicle to notify the owner of the impending towing. If within one hour of attempted notification, the vehicle shall be deemed as a hazardous condition to the snow and ice removal efforts of Cumberland Township and be subject to towing. If, at any time, during a period of snow emergency declared under § 21-201, a person shall park a motor vehicle or allow a motor vehicle to remain parked anywhere on the roads or in the right-of-way in such a manner as to impede or obstruct the snow and ice removal operations of Cumberland Township or create a hazardous condition, that person shall be guilty of a violation, and upon, shall be sentenced to pay a fine of \$50 and costs.

# From your Maintenance Department...

## 2025/26 Winter Maintenance Newsletter

Winter is an especially busy time for the Cumberland Township Maintenance Department. Not only are we prepared 24 hours a day 7 days a week in moment's notice to fight any winter weather Mother Nature throws at us, but the winter season is also a time that we perform maintenance on our equipment and prepare for projects for the upcoming season.

Crews will continue mapping the township stormwater facilities throughout the township using the GIS mapping system. These crews will be in an official township vehicle and will have official township identification. This mapping is being completed to comply with the Townships MS4 (Municipal Separate Storm Sewer) mapping which is required for state and federal compliances. Mapping is also used internally to track upgrades, age and capacities of the collection systems.

There will be various street name sign upgrades around the township in areas that projects were conducted this summer. These signs along with speed limit, roadway warning and directional signs will be utilizing a Hi-Viz material to help motorists identify the signs easily.

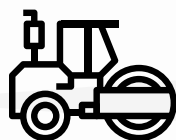
Also, a big part of the winter season is tree trimming and removal of dead or hazardous trees. This task helps with improving site distances and allowing sunlight to get to the roadways to help with thawing during winter weather.

Winter weather events can be hazardous to the traveling public. When winter weather strikes, the Maintenance Department is out in full force striving to keep the roadways safe for the traveling public. Please use caution when approaching snow removal equipment. The township uses Savvy Citizen, along with various local news media and public service

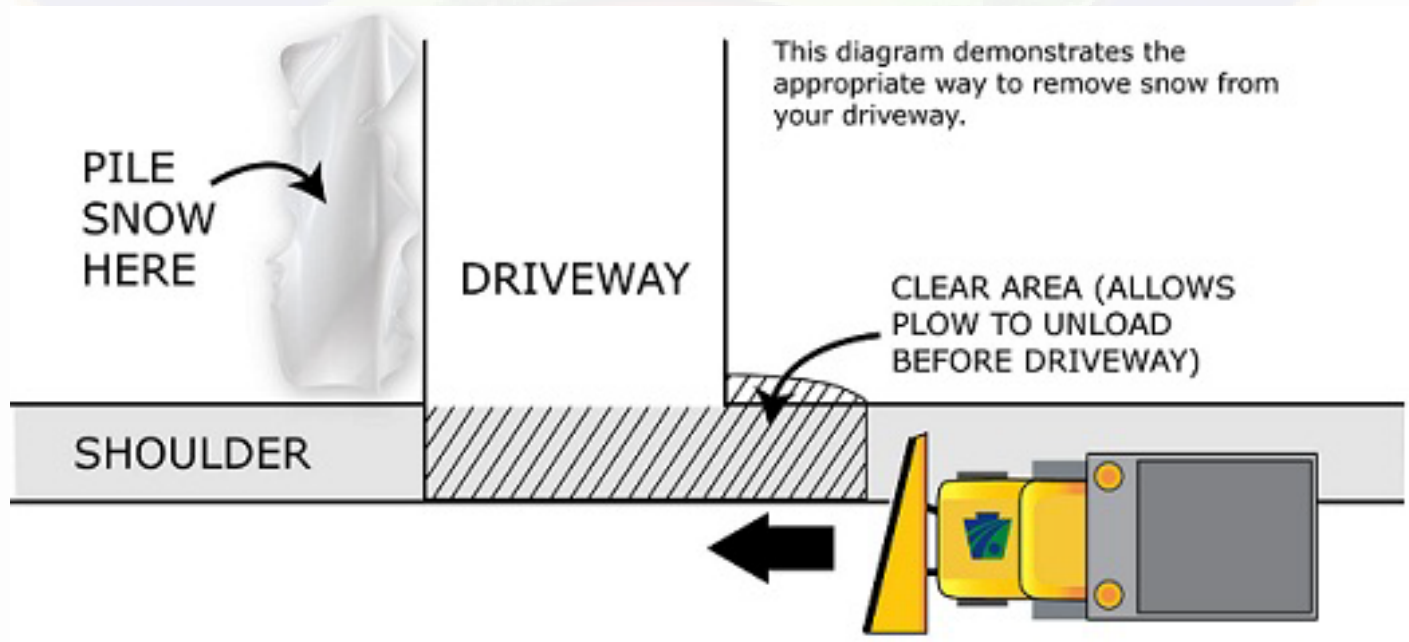

## October 13, 2025 – Your Sewer Authority's New Home

After years of dedicated service and steady growth, the Cumberland Township Authority (CTA) has officially relocated its administrative office to a new space that better reflects our evolving needs and commitment to the community.

This move marks a significant milestone in our journey. Over the years, CTA has grown in both service area and responsibility, consistently working to fulfill our mission: *to responsibly manage and treat wastewater in a way that safeguards public health, protects our waterways, and preserves the environment for generations to come.* Our team has expanded, our infrastructure has modernized, and our service area has become more complex, all requiring a space that supports our operations and values.

The new office is now located adjacent to our Operations offices at the South Wastewater Treatment Plant, a strategic decision that enhances collaborative efforts between our administrative and operational teams. This proximity allows for more efficient communication and support, ultimately benefiting our customers.

For decades, CTA operated as a tenant within the shared municipal building alongside Cumberland Township and the Cumberland Township Police Department. # Let's Talk Storm Water!

Winter is here, so it is time to ensure that your property is ready for the snow, ice and the melting runoff. Effective stormwater management during winter months is necessary for the prevention of flooding, protection of infrastructure and reducing water damage. Some winter stormwater maintenance tips to assist in your keeping your property safe and your stormwater systems functioning properly include:

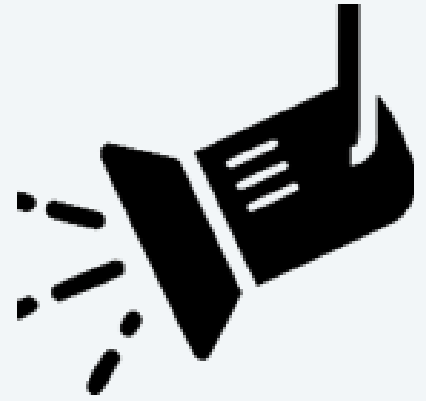
❄ Inspecting and clearing gutters, downspouts and drainage systems around your property. Accumulation of leaves, debris and ice can prevent proper drainage. Ensure French drains, swales and catch basins are free-flowing and free of ice to prevent flooding.

❄ While salt and de-icing agents are important to keep sidewalks and driveways safe, they can negatively impact stormwater runoff. Excess salt can contaminate local waterways and harm vegetation and aquatic life. Use de-icing agents sparingly and consider using alternatives such as sand or non-toxic ice melts. Remember - when the temperature drops below 15 degrees, salt is not effective. Also, shovel early as the more snow that is removed, the less de-icing agents will be needed. After storms, be sure to clear away any excess salt or de-icing materials to prevent them from washing into stormwater drains.

❄ Avoid piling snow near storm drains, catch basins and drainage systems. Piled snow on top of drainage infrastructures can block water flow and contribute to ice formation or flooding as snow begins to melt. Place snow piles in areas that will not block water runoff or drainage systems and have the best opportunity to be absorbed into the ground.

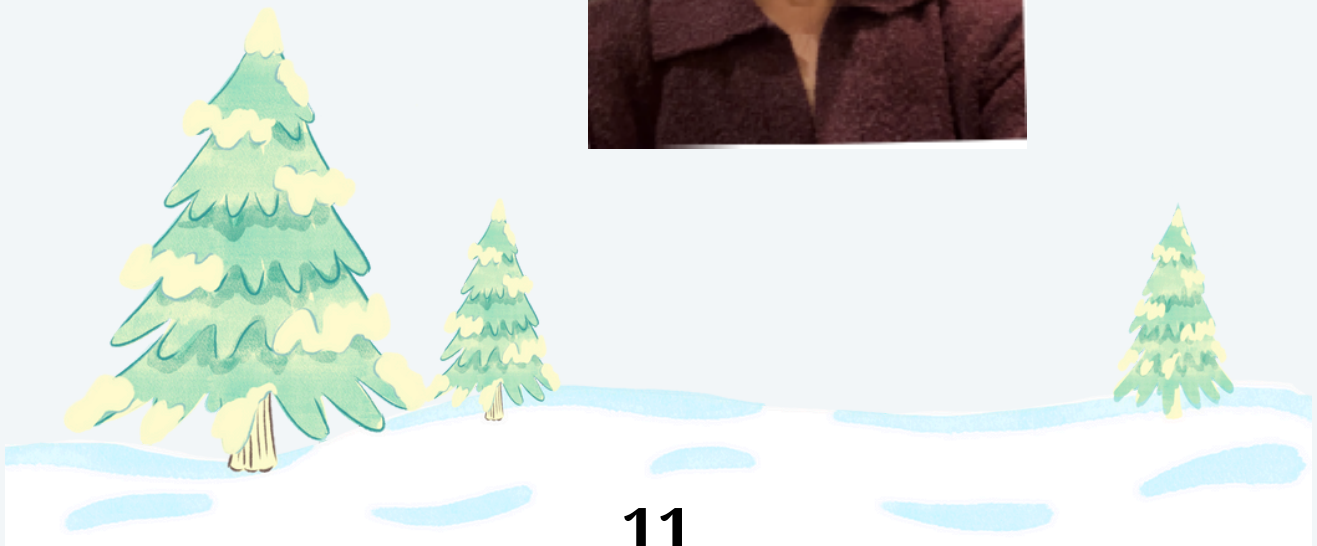
**Meet Anita!**

CTA Board (Cumberland Township Authority) - the governing body of the municipal sewer authority.

GARA (Gettysburg Area Recreation Authority) - within its mission focus, the Gettysburg Area Recreation Authority has been established to organize year round programs and services to help sustain better health and wellness in our community.

HARB (Historical Architectural Review Board) - reviews and makes decisions regarding architectural design, landscaping, and signs for historic resources and buildings within historic districts.
