




YCPC would like to share a recently completed project in Delta Borough. The Main Street Curb, Sidewalk, and ADA Improvements Project (300 Block) was completed on August 30, 2025.

This Community Development Block Grant (CDBG) Public Works project consisted of the replacement of concrete curbs and ADA sidewalk ramps in Delta Borough.

The improved area included the removal and disposal of the existing sidewalk, curbing, and pavement, and installation of a new concrete curb, a compliant ADA sidewalk, and associated pavement restoration. Overall, the project included approximately 900 LF of curb and sidewalk and two (2) ADA ramps on the 300 block of Main Street.

This project was funded by a CDBG grant from the U.S. Department of Housing and Urban Development (HUD), totaling \$222,181.50. The grant application was submitted in January 2024, awarded in November 2024, and work was completed from June 30 to August 30, 2025. Kinsley Construction, LLC, of York, PA, constructed the work.

Bells Across PA - November 14, 2025

York County, along with America 250PA, unveiled six fiberglass bells designed by local artists to commemorate the 250th Anniversary of the United States in 2026.

The Pennsylvania Commission for the United States Semiquincentennial (America250PA) was established by the legislature and Governor Wolf in 2018 to plan, encourage, develop, and coordinate the commemoration of this founding of the United States in 1776, Pennsylvania's integral role in that event, and the impact of its people on the nation's past, present, and future.



In July 2025, York County, America250PA, and Springettsbury Township unveiled a bronze commemorative Semiquincentennial Bell at Camp Security Park, one of the only known Revolutionary War prison camps remaining in the United States. The Semiquincentennial Bells are part of America250PA's preservation mission to highlight historically significant locations across the Commonwealth.

The Bells Across PA art series is another initiative of America250PA. This program offers local artists across the Commonwealth the opportunity to design a three-foot fiberglass bell to commemorate the Semiquincentennial. Artists created design ideas and submitted them to be chosen by the bell's sponsor. Bells designed by artists will be displayed in all 67 counties. This program encourages visitors across the commonwealth to visit, touch, and feel the designs, connecting them more closely to their community, state, and nation.

On November 14, 2025, we unveiled six fiberglass bells that will be displayed in six locations along portions of the rail trails across York County.

This commemoration event would not be possible without the support of our sponsors, including the Powder Mill Foundation, the Arthur J. and Lee R. Glatfelter Foundation, the J. William Warehime Foundation, the Graham Foundation, the Kinsley Foundation, FirstEnergy, America 250PA, and York County.

## York County Planning Commission (YCPC) Announces Key Leadership Promotions

The YCPC is pleased to announce two staff promotions approved at the Planning Commission's November meeting. The YCPC Board unanimously approved promoting Mr. George Barnock to Assistant Director and Mr. Roy Livergood to Chief of Long-Range Planning.

Mr. Barnock moves into the Assistant Director role from his current position as Chief of the Programs Management and Compliance Division. He has been with YCPC for over 23 years, beginning as an intern supporting the Long-Range Planning, Transportation, and Municipal Planning divisions. He is a certified U.S. Department of Housing and Urban Development Programs Regulation Specialist and a member of the American Planning Association. Mr. Barnock has led the Programs Management and Compliance Division since 2013, with prior experience as the Chief of the Housing Division and as a Community Development Coordinator. Throughout his tenure, he has managed a wide range of federal, state, and local housing and community development programs.



Mr. Livergood's promotion from Senior Planner to Chief of the Long-Range Planning Division follows the retirement of Ms. Pamela Shellenberger, who will conclude 42 years of full-time service with YCPC at the end of the year. YCPC and the Board extend their sincere appreciation to Ms. Shellenberger for her dedicated service to the York County community. Mr. Livergood has served YCPC for more than 29 years, beginning his career in 1996. Before joining the agency, he interned with PennDOT and for the Clearfield County Planning Commission. Roy serves on the Local Emergency Planning Committee and the Pennsylvania Silver Jackets. As the County Hazard Mitigation officer, he is responsible for updating and implementing the York County Hazard Mitigation Plan. His planning work has received local and state awards, including recognition for York's Envisioned Scenarios 2040 and the York County Heritage Preservation Plan.

## Municipal Spotlight Springfield Township



Springfield Township developed from its rural roots into a suburban community through a history of planning to preserve farmland while also allowing for growth. The township adopted a <u>Transfer of Development Rights (TDR) program</u> in the early 1990s.

This strategy allowed for the preservation of agricultural land and sensitive areas while guiding new development to designated growth zones, leading to a mix of historic small-town housing, farms, and modern subdivisions that exist today. As of 2020 census Springfield Township is now home to approximately 6,026 residents over 27 square miles.

Springfield Township most recently completed addition to our maintenance building allowing our Road Crew to better service the increased infrastructure demands experienced from our residential/business growth over the recent years.

In terms of municipal projects and plans, Springfield Township most recently supported the York Water Company project at Lake Williams. As well as infrastructure upgrade to bridge work on Log Rd., all which support an active outdoor lifestyle our residents appreciate as part of their everyday living experiences in our Township.





Going into 2026 many exciting projects are happening, St. Peters Church planning a 9,000 square foot addition, Eden Tools have been approved for construction of a new manufacturing facility, Adhesive Research also has presented a Land Development Plan for additional manufacturing facility, growth continues in our municipality as we are committed to searching out new and innovative paths forward to best service our Community as a whole.
