PLACE:

Beginning: Starting at Blackwater in Yankeetown 6301 Riverside Dr, Yankeetown, FL 34498-2364

End: The Inglis Community Center – ICC (behind Town Hall)

LINE UP: will begin at Blackwater as early as 3:30 pm but NO LATER THAN 4:30 pm. IDENTIFICATION is not mandatory but *recommended* and should be displayed on the front (preferred) or **driver** side of the entry.

ROUTE: (Blackwater)- 6301 Riverside Dr, Yankeetown, FL 34498, Head northwest on Riverside Dr, Turn right onto Riverside Dr, Bear right onto Highway 40 W. Continue THROUGH parking lot to utility easement behind Inglis Community Center (I.C.C.). Approximate length is 2.9 miles.

You must maintain a **20-foot distance** between entries.

ENTRY FEE: None

CANDY: No throwing of this or any other items, **however**, items may be handed out.

DECORATION: Floats will be viewed from both sides of the street.

VOLUNTEER HOLD HARMLESS AGREEMENT (DISCLAIMER)
