- A. Chapter 485 Vehicles & Traffic, Article IV. General Parking Regulations - to include "A annual \$25 parking permit required for vehicles parking in the North Street Borough Parking lot, which must be displayed in the rear window of the vehicle. Vehicles must be moved weekly to allow parking lot maintenance. All

vehicles found not having a current parking permit will be towed at owner expense.

- B. Chapter 411 Solid Waste, Garbage and Refuse Collection, 411-5 Rates, fees or charges added to monthly Public Water invoice as first line item on the invoice. Solid Waste fees, deposits et to remain in the Landlords name.
- C. Chapter 505 Water & Sewer System, Article I. Payment of Bills for Multi-Unit Rentals, should read Single & Multi-unit Rentals shall remain in the Landlords name, Landlord being responsible for all fees & security deposits.
- D. Chapter 400 Rental Property, Article I. Tenant Registration, should read - Landlord & Tenant Registration, to include rental property inspection every two - three year and rental property inspection required prior to new tenant move in. Inspection Fee to be paid by landlord. Landlord is to furnish a tenant registration, which list all individuals over the age of 18 years of age at time of each property inspection.
