AN ORDINANCE OF THE TOWN COUNCIL OF THE TOWN OF YANKEETOWN, FLORIDA SUBMITTING TO REFERENDUM AN AMENDMENT TO THE TOWN CHARTER; REPEALING SECTION 11 of THE TOWN CHARTER TO REMOVE THE REQUIREMENT FOR VOTER APPROVAL OF CERTAIN COMPREHENSIVE LAND USE PLAN ADOPTIONS OR AMENDMENTS; PROVIDING FOR A NOTICE OF AN ADVERTISEMENT OF THE REFERENDUM ELECTION TO BE PUBLISHED IN ACCORDANCE WITH LAW; PROVIDING THAT THIS ORDINANCE, WHEN ADOPTED, SHALL BE SUBMITTED TO THE QUALIFIED ELECTORS OF THE TOWN OF YANKEETOWN, FLORIDA, ON THE APRIL 2024 MUNICIPAL GENERAL ELECTION BALLOT; PROVIDING FOR AN EFFECTIVE DATE.
