AN ORDINANCE OF THE COUNCIL OF THE BOROUGH OF ABBOTTSTOWN, ADAMS COUNTY, PENNSYLVANIA, AMENDING ORDINANCE No. 2019-04 AND 2024-03, AS CODIFIED IN CHAPTER 197 OF THE CODE OF THE BOROUGH OF ABBOTTSTOWN RELATING TO GENERAL PARKING REGULATIONS  
ORDINANCE No. 2025- 01

The Council of the Borough of Abbottstown, Adams County, Pennsylvania, enacts and ordains:

**SECTION 1**

Ordinance 2024-03 is hereby amended as follows:

§ 402, Section 1, items U thru LL, where stated “**at any time,**” shall now read “**during weekdays from 6:00 am to 5:00 pm, except for Borough-recognized holidays, to include New Year’s Eve and Day, Memorial Day, Independence Day, Labor Day, Thanksgiving Day, Christmas Eve and Day.**”

Chapter 197, A, § 197-25, items 21 thru 33 of the Code of the Borough of Abbottstown are hereby amended as follows:

§ 197-25, Section A, items 21 to 38, where stated “**at any time,**” shall now read “**during weekdays from 6:00 am to 5:00 pm, except for Borough-recognized holidays, to include New Year’s Eve and Day, Memorial Day, Independence Day, Labor Day, Thanksgiving Day, Christmas Eve and Day.**”

**SECTION 2**

All Ordinances or Resolutions or parts of Ordinances or Resolutions which are inconsistent herewith are hereby repealed to the extent that the same are inconsistent with the terms of this Ordinance. Nothing in this legislation hereby adopted shall be construed to affect any suit or proceeding pending in any court, or any rights acquired, or liability incurred, or any cause or causes of action acquired or existing, under any act or ordinance hereby repealed; nor shall any just or legal right or remedy of any character be lost, impaired, or affected by this Ordinance.

**SECTION 3**

If any section, subsection, sentence, clause, or phrase of this Ordinance is, for any reason, held to be unconstitutional, such decision shall not affect the validity of the remaining portions of this Ordinance. The Borough of Abbottstown hereby declares that it would have passed this Ordinance, and each section, subsection, clause, or phrase thereof, irrespective of that fact that any one or more sections, subsections, sentences, clauses, and phrases be declared unconstitutional.

**SECTION 4**

The Code of the Borough of Abbottstown, as amended, shall be and remain unchanged and in full force and effect except as amended, supplemented, and modified by this Ordinance. This Ordinance shall become a part of the Code of the Borough of Abbottstown, as amended, upon enactment.

**SECTION 5**

This Ordinance shall be effective immediately following its legal enactment.

Dear Abbottstown Borough,

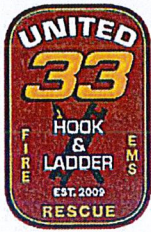
I am writing to express our support for lifting the side street parking ban during holidays, evenings, and weekends in Abbottstown Borough.
