DEADLINE FOR SUBMITTING APPLICATION/DISCLAIMER

Thursday, December 11 at 3pm at either Inglis or Yankeetown Town Halls.

DISCLAIMER MUST BE SUBMITTED WITH APPLICATION

THEME: Anything Christmas
PLACE: Beginning lineup at the Chamber of Commerce Building CR 40 W
END: Yankeetown Pavilion
ROUTE: Follow that Dream Parkway West To East Riverside Dr to YT Pavilion

You must maintain a 20-foot distance between entries

SANTA: **Only one Santa** (or Santa look-alike) will be in the Parade, which will be provided by the committee. Elves OK

CANDY: **No throwing of candy or any other items.**

Candy may be handed out along the parade route NOT **THROWN**

ANIMALS: All animals MUST have a clean-up crew! This includes the staging area.

DECORATIONS: Floats will be viewed from both sides of the street

IF YOU DONOT ADHERE TO THESE RULES/INFORMATION, YOU RUN THE RISK OF NOT PARTICIPATING IN THE PARADE OR NOT BEING ALLOWED TO PARTICIPATE IN THE FUTURE.

PARTICIPATION HOLD HARMLESS AGREEMENT(DISCLAIMER)
