A Performance and Payment Bond, each in the amount of one hundred percent (100%) of the estimated contract price, shall be required from the Successful Bidder. A non-collusion affidavit is required for this Bid.

The Project is subject to the Pennsylvania Prevailing Wage Act, Act of August 15, 1961, P.L. 987, as amended and supplemented, and appropriate prevailing minimum wage rates.

Successful bidders, including all Prime Contractors, subcontractors and third tier subcontractors shall furnish Certificates of General Liability Insurance naming Cumberland Township, Commonwealth of Pennsylvania, and Commonwealth Financing Authority as "Additional Insureds".
