- Christmas Lights Electrical Issue - recurring outage is due to outdated glass breakers in individual electrical boxes for ornamental lights. A faulty breaker trips the main breaker, shutting down all lights on S. and N. Main Street. Engles & Fahs estimate for phased replacement \$3500

- Zoning Hearing Board Meeting scheduled for January 13, 2026 – 675 S. Main Street (Special Exception for auto repair, state inspection, and auto sales). Determine if Council wishes to participate as a party.
- Approval to work on amending § 20-207 Yard Waste, Grass Clippings and Leaf Waste. Currently states, “Leaf waste shall be placed on a pile or row on the street for collection in the fall of the year at times designated by the Borough and at any other time designated by the Borough. The pile or row shall be located on the street outside of the traffic lanes approximately one foot from the edge of the curb in such a manner as will allow safe passage of vehicles and also allow for proper stormwater drainage. This goes against MS4 (stormwater) guidelines and creates a plethora of other issues as well. We need to change this before next season.
