Manager Hart led the Pledge of Allegiance.

### **Public Comment**

Andrew Berenson of 439 Washington Avenue thanked the members of the Zoning Hearing Board and the members of the audience that attended the most recent hearing for the property formerly known as McKeever's located at 501 E. Walnut Street. The hearing lasted several hours, and despite the length and process, the Board and public maintained professional.

### **Consideration: Appointment to fill Council Seat Vacancy (Ward One)**

Council interviewed the following candidates for the Ward 1 Council vacancy: Candace Anderson, 201 W. Walnut Street, Zane Swanger, 301 Center Street, and Jeffery Ferguson, 301 West Montgomery Avenue.

President Amato reviewed the procedures for interviewing the candidates and clarified how the process works. He referred to guidance documents which listed the standard operating procedures when Council appoints to fill a vacancy.

President Amato called for nominations to fill the Ward One Council vacancy. Member Fazio nominated Candace Anderson. Vice President Tarlecki nominated Zane Swanger. Member Groce nominated Jeffery Ferguson. No other nominations were called for.

Manager Hart took a roll call vote for Candace Anderson. Motion passed, 5 yes, 3 no. Member Groce, Member McClure, and Vice President Tarlecki voted no.

In the absence of the Mayor, Council President Amato swore Member Anderson into office, term expiring 12/31/2025, fulfilling Council Seat Ward One vacancy left by Member Brittany Kohler. Member Anderson was welcomed by Council members and joined the meeting as a newly appointed member of Council.

Member McClure made a motion to Approve the August 12<sup>th</sup> Meeting Minutes. Member Neiderhiser seconded the motion. Motion passed 9 yes, 0 no.

Member Groce made a motion to Approve the Acceptance of Resignation of Salvatore Amato, Council Ward 3. Member Neiderhiser seconded the motion. Motion passed 9 yes, 0 no.

Gregory D'Angelo of 915 E. Montgomery Avenue expressed his experiences with President Amato and his appreciation for his work in the Borough.

There was no Old Business, Committee or Board Reports, Zoning Applications, or Parking Lot to be discussed.

### **Solicitor / Mayor / Council / Chief / Public Works / Manager**

Solicitor Gifford announced that there will be an executive session after the meeting to give an update on litigation and a personnel matter but did not anticipate any action being taken.

There was no Mayor's report.

Member Whelan welcomed Member Anderson to the Council and thanked President Amato for his service and leadership. Members Groce, Neiderhiser, Fazio, and McClure also thanked President Amato for his leadership and for taking the time to teach them and listen to their perspectives. Vice President Tarlecki added his appreciation for President Amato's leadership and hard work.

Member Fazio further thanked the three candidates for their interest in the Council Vacancy and congratulated Member Anderson on her appointment.

Member McClure asked about the status of the North Wales Arts and Cultural Center. Manager Hart explained that there are a few potential bookings, in addition to the non-profit center being used and the organ recitals.

Member Hart gave updates on the Parks and Recreation Board's Summer Scavenger Hunt, the North Wales Library Farm to Table Gala, the Walk and Track Program, the After-School Art Club, and Community Day events coming up in September.

**BOROUGH OF NORTH WALES**  
**RESOLUTION 2025-050**  
**A RESOLUTION ESTABLISHING POLICE GUIDELINES AUTHORIZING AN**  
**ARREST WITHOUT A WARRANT IN ACCORDANCE WITH ACT 25 OF 1995**

**WHEREAS**, on November 17, 1996, the Governor of the Commonwealth of Pennsylvania signed an Act known as Act 25 of 1995; and

**WHEREAS**, Title 42 of Pennsylvania Consolidated Statutes was amended by adding Section 8902 authorizing an arrest without a warrant for certain specific summary offenses; and

**WHEREAS**, 42 Pa. C.S.A. Section 8902(8) provides that the governmental body shall promulgate guidelines to be followed by a police officer when making a warrantless arrest under 42 Pa. C.S.A. Section 8902.

**NOW, THEREFORE, IT IS HEREBY RESOLVED AS FOLLOWS:**

Section 1. Prior to making an arrest under 42 Pa. C.S.A. 8902, any police officer shall ensure that:

(a) He/she has probable cause to believe that at least one of the following summary offenses is being committed:

- (1) 18 P.S. 5502 (Failure of disorderly person to disperse)
- (2) 18 P.S. 5503 (disorderly conduct)
- (3) 18 P.S. 5505 (public drunkenness)
- (4) 18 P.S. 5507 (obstructing highways and other public passages)
- (5) 18 P.S. 6308 (purchase, consumption, possession or transportation of liquor or malt or brewed beverages);

(b) The suspect's conduct is ongoing;

(c) The conduct constituting the offense is in the officer's view; and

(d) The conduct imperils the personal security of any person or endangers public or private property.

Section 2. Following an arrest pursuant to 42 Pa. C.S.A. 8902, the officer shall forthwith satisfy the procedures set forth in Pennsylvania Rule of Criminal Procedure 71 (Procedure following arrest without warrant).



**NOW, THEREFORE, BE IT RESOLVED BY THE NORTH WALES BOROUGH COUNCIL:**

That the North Wales Borough Council hereby adopts the aforementioned guidelines to be followed by a police officer when making a warrantless arrest under 42 Pa. C.S.A. Section 8902.

The North Penn Volunteer Fire Company (NPVFC) recently purchased two mobile data terminals (MDTs) with the \$3,460 in donations received in memory of Mike McAdoo, who passed away on August 29, 2024. The MDTs provide amazingly useful technology to assist the NPVFC with its mission. When a fire or EMS call is received, the MDTs provide vital information about the call, location, directions to the call (very helpful when covering calls for other stations), fire hydrant locations and size, along with any other information dispatch provides. The MDTs also allow communications with Montgomery County without using the fire company radios, which keeps the radios for emergency traffic only and is very helpful during major county-wide incidents.
