Cumberland Township Municipal Building Project Overview May 28, 2024

- 1979 Arthur Lea Stabler & Associates of Hanover, PA constructed the Cumberland Township New Office Building and attached Garage.
- 1994 New Office addition to existing Administration Building for Police Operations.
- 2001 & 2015 Space Utilization studies were performed by C.S. Davidson Inc. of Gettysburg.
- 2016 Action Plan was initiated with the formation of a Building & Grounds Committee. Several reviews and public meetings with full transparency chaired by Supervisor Barbara Underwood, Jim Paddock, and Maintenance Superintendent Chris Walter
- April 2019 Homeland Security provided a "Security of Soft Targets and Crowded Places" Resource Guide.
- May 31, 2019 US Dept. of Homeland Security presented the Township a Security & Resilience Report: Infrastructure Survey report. For security purposes this is an extensive report of vulnerabilities and options for consideration – Not a public document.
- Several additional security studies have been completed and are in possession of Cumberland Township Police Department
- 2020 Covid Illness Impact on Employees Due to the cramped working environment of the Police Department, employees are prone to close contact with each other. This may have contributed to an outbreak of COVID that affected all officers in late 2020. PA State Police managed incidents while the Police Department was closed.
- October 31, 2022 Governor Wolf authorized \$1,300,000.00 in Redevelopment Assistance Capital Program – Also referred to as "RACP."
- September 12, 2023 Open Workshop to discuss RACP Grant
- October 16, 2023 Redevelopment application submitted as outlined in award letter working with GMS.
- November 28, 2023 The Township entered into a Professional Services Agreement with Kinsley Construction for Construction Design and Construction Management Services.

- November 30, 2023 Commonwealth Financing Authority Statewide Local Statewide Authority "LSA" grant submitted for \$100,000.00 to be used for new building security measures.
- December 19, 2023 Applied for additional \$700,000.00 RACP matching funds.
- January 2024 to Present Working with Kinsley, Building Committee, and Staff to combine all information into a plan and bid ready format for consideration.
- May 28, 2024 Seek approval for the solicitation of proposals for draw down and permanent financing for the building renovation project in the maximum amount of \$4,500,000.00
- May 28th, 2024 Seek approval to enter a Lease Agreement with American Battlefield Trust thru March 31, 2026. This is to relocate the Administration and Police during the proposed building renovation. The Lease is \$0.00, however, the Township will be responsible for any maintenance repairs, utilities, and 1/3 mowing costs during that period.
- June 18th @ 4:00 PM Building workshop at Cumberland Township.
- Continuation of evaluating other grant and funding opportunities.

 \$2,900,000.00 11,168SF (\$260 per SF)
- Convert current building to Police Department & construct new Admin Building \$3,295,000.00 12,500SF (\$264 per SF)
- 3) All New Building\$3,400,000.00 11,168SF (\$305 per SF)

May 2024 - Updated Building Estimates:

\$4,319,671.50 – Building Project (Currently includes 5% contingency)

May 2024 - Budget Overview Estimate:

- \$4,350,000.00 Total with estimated
- \$1,300,000.00 RACP Funding awarded 50% Match
- \$ 527,434.89 Building Fund
- \$ 782,445.76 Loan 50% RACP Match
- \$1,740,119.35 Balance

May 2024 - Additional Funding Applications submitted:

- \$ 100,000.00 Applied LSA Grant Security
- \$ 700,000.00 Applied for additional RACP Grant Funding

Finance Considerations:

\$2,000,000.00 30 year 4.5% = \$10,133.71 Monthly Approximate six months - \$60,000.00 already in 2024 Budget

Vision:

The primary focus of building renovations revolves around a larger footprint for the Police Department. Seventy-Five (75) % of this project expands, secures, and brings Cumberland Townships Police Department to acceptable standards. These standards include office space, interview room, secure evidence room, locker rooms, and shower facilities. The building will be ADA Compliant allowing full accessibility to all Cumberland Township residents including an updated public meeting room and a public bathroom. In addition to normal Township meetings other township business such as HOA meetings could be held after hours when available. The new secure entrance and additional security features will help keep the building and staff safe and secure.
