NOTICE is hereby given that the Board of Supervisors of Codorus Township, York County, Pennsylvania, that a public hearing on a proposed amendment to the Code of the Township of Codorus, Zoning, will be held on Thursday, September 4, 2025, at 7:00 p.m. at the Codorus Township offices 4631 Shaffers Church Road, Glenville, PA.

The Ordinance proposing the amendment to the Code of the Township of Codorus is entitled, "AN ORDINANCE OF CODORUS TOWNSHIP, YORK COUNTY, PENNSYLVANIA, AMENDING THE CODE OF THE TOWNSHIP OF CODORUS, CHAPTER 250 ZONING, ARTICLE III, SECTION §250-9, ENTITLED "DEFINITIONS" TO ADD THE DEFINITIONS OF "MILL" AND "SAWMILL"; AND AMENDING THE CODE OF THE TOWNSHIP OF CODORUS, CHAPTER 250 ZONING, ARTICLE V ENTITLED "AGRICULTURAL DISTRICTS (A)," SECTION §250-14 C(12), ENTITLED "PRINCIPAL USES PERMITTED BY SPECIAL EXCEPTION" TO EXCLUDE SAWMILL."

The proposed amendment to the Zoning Ordinance amends the Code of the Township of Codorus to define "mill" and "sawmill" and to exclude "sawmill" from the principal uses permitted by special exception in the agricultural district.

The Board of Supervisors proposes to adopt the amendments to the Code of the Township of Codorus at the regularly scheduled public meeting of the Board immediately following the aforesaid hearing.

A copy of the proposed Ordinance may be examined without charge at the Township offices during normal business hours. A copy of the proposed Ordinance has been filed with the York Newspaper and the York Law Research Center, 45 N George St, York PA. Interested citizens are invited to attend the aforesaid public hearing and the regular meeting of the Board of Supervisors of Codorus Township immediately following the public hearing and offer comments on the proposed amendments to the Code of the Township of Codorus.

# CODORUS TOWNSHIP YORK COUNTY, PENNSYLVANIA

AN ORDINANCE OF CODORUS TOWNSHIP, YORK COUNTY, PENNSYLVANIA, AMENDING THE CODE OF THE TOWNSHIP OF CODORUS, CHAPTER 250 ZONING, ARTICLE III, SECTION §250-9, ENTITLED "DEFINITIONS" TO ADD THE DEFINITIONS OF "MILL" AND "SAWMILL"; AND AMENDING THE CODE OF THE TOWNSHIP OF CODORUS, CHAPTER 250 ZONING, ARTICLE V ENTITLED "AGRICULTURAL DISTRICTS (A)," SECTION §250-14 C(12), ENTITLED " PRINCIPAL USES PERMITTED BY SPECIAL EXCEPTION" TO EXCLUDE SAWMILL.

WHEREAS, Codorus Township previously enacted the Codorus Township Zoning Ordinance, Chapter 250, Zoning, of the Code of the Township of Codorus; and WHEREAS, Codorus Township wishes to amend Chapter 250 of the Code, Article III, §250-9, entitled "Definitions," to add the definitions of mill and sawmill; and WHEREAS, Codorus Township wishes to amend Chapter 250 of the Code, Article V entitled "Agricultural Districts (A), §250-14C(12), entitled "Principal uses permitted by special exception," to exclude sawmill as a use permitted by special exception; and WHEREAS, Codorus Township has held a hearing pursuant to public notice to receive testimony concerning the proposed amendment to Section of the Code of the Township of Codorus.

**NOW, THEREFORE,** be it enacted and ordained and it is hereby enacted and ordained by the Board of Supervisors of Codorus, York County, Pennsylvania as follows:

1) The Code of the Township of Codorus is hereby amended by adding the definitions of Mill and Sawmill to the existing definitions set forth in the Code of the Township of Codorus Chapter 250, "Zoning," Article III "Terminology," §250-9 "Definitions," to read as follows: PERSONAL USE SAWMILL – An sawmill which is used for personal use only, is used only for materials grown on the property, is not used to prepare any wood product for sale or distribution, and occupies no more than one acre of land including storage of any prepared wood. MILL – a building provided with machinery for processing and especially for grinding grain into flour and producing feed.

**SAWMILL** – a principal use devoted to the processing of natural wood products into semi-finished products for distribution.

2) The Code of the Township of Codorus is hereby amended by adding the exclusion of sawmill from the existing principal uses permitted by special exception set forth in the Code of the Township of Codorus Chapter 250, "Zoning," Article V "Agricultural Districts (A)," §250-14 "Use regulations," C(12) "Principal uses permitted by special exception", to read as follows: (12) Mill, including, but not limited to, feed and grain mills, but excluding sawmills, which are defined separately under this Ordinance.

3) The Code of the Township of Codorus is hereby further amended by adding Personal Use Sawmill as an accessory use permitted by right in the Agriculture Zoning District, as set forth in the Code of the Township of Codorus Chapter 250, "Zoning," Article V "Agricultural Districts (A)," §250-14 "Use regulations," (B), "Accessory uses", which amended by amending number 16 to read "(16) Personal Use Sawmill", and adding number 17 to read "(17) Any other use customarily incidental to any of the uses permitted by this section as principal uses.  Accessory uses in Subsection B(1), (4), (7), (8), (12) and (14) shall be permitted as accessory only to principal use in Subsection A(4). Accessory uses in Subsection B(10) and (11) shall be permitted as accessory only to principal use in Subsection A(3). Accessory uses in Subsection B(5) and (6) shall be permitted only as accessory to principal use in Subsection A(1). Accessory use in Subsection B(13) shall be permitted as accessory only to principal uses in Subsection A(3) and (5)."  4) This Ordinance shall become effective as provided by law.
