APPROVING MASTER EQUIPMENT LEASE AGREEMENT BY AND BETWEEN THE CITY OF LATROBE AND FIRST COMMONWEALTH EQUIPMENT FINANCE CONCERNING COMMERCIAL VEHICLES

WHEREAS, the City of Latrobe intends to lease commercial vehicles to be used as part of the City's waste collection program; and,

WHEREAS, the City of Latrobe has determined that not acquiring capital assets is in its best financial interest. A five (5) year lease will meet this goal and does not exceed the useful life of commercial sanitation vehicles; and,

WHEREAS, the City of Latrobe has applied for a grant to assist with the operation of its waste collection services and determined that a five (5) year lease will maximize the efficient use of the grant money should the City be awarded the grant; and,

WHEREAS, a five (5) year lease that provides the City the authority to terminate it in the event funds are not appropriated to make the lease payment during a future fiscal year.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Latrobe, in a regular meeting assembled and by authority of the same:

SECTION 1. It is resolved that the Mayor, Interim City Manager and Director of Public Works are authorized to sign a Master Equipment Lease Agreement with First Commonwealth Equipment Finance, a division of First Commonwealth Bank, and attached schedules and riders. Said documents include the Lessee Resolution attached hereto.

SECTION 2. The commercial vehicle being leased is a 2025 Hino L7 VIN 5PVNV7AM0S5T50283 S/N RLM132024020086.
