## **Finance Committee**

Motion to approve repayment of the 2024 TAN Loan (Tax Anticipation Note) in the amount of \$300,000.00 plus interest of \$1,190.00 effective until June 21, 2024.

Motion to extend the Cargill Inc. agreement to purchase the minimum 2023-2024 winter season salt purchase requirement for the first option year to December 31, 2024 and exercise the second option year of the contract with Cargill Inc. to provide rock salt for the 2024-2025 winter season at a bid price of \$85.85 per ton.

Note: 80% of estimated 600 ton for 2023-2024 (480 ton) to be purchased by 12/31/24, otherwise, pay Storage \$10/ton <u>and</u> obligated purchase the balance at 2024-2025 prices. Estimated 400 for 2024-2024 (320 ton) season. Approximately 400 ton currently on-hand.

### **Public Safety Committee**

Motion to approve a 5 year lease agreement with Axon Enterprise, Inc., for Axon-10 Tasers including battery packs, docking station, cartridges, holsters and associated certifications, licensing, software and warranties beginning August 15, 2024 through September 14, 2029, for a total cost of \$20,470.40.
