

**LATROBE CITY COUNCIL  
REORGANIZATION/SPECIAL MEETING  
MONDAY JANUARY 5, 2026  
LATROBE, PENNSYLVANIA**

Mayor Bartels called to order the yearly Reorganization Meeting of Latrobe City Council at 6:45 P.M.

Mayor Bartels asked all to rise for the Pledge of Allegiance.

Mayor Bartels asked all for a moment of silence.

Eric Bartels, who was reelected as Mayor, was sworn into office by Magistrate Mahady. Councilmember Ann Amatucci, who was reelected, was sworn into office by Magistrate Mahady.

Newly elected Councilmembers, Sam Leach and Eric Hauser, were sworn into office by Magistrate Mahady.

Mayor Bartels recognized Jim Kelley, former Councilmember and Solicitor, along with his wife, Dr. Kathleen Kelley, former member of the Planning Commission, for their time and civil service to the City of Latrobe and the community. Mr. Kelley had spent 50 years serving as the city Solicitor and then as a Councilmember. Mrs. Kelley served on the Planning Commission. Mayor Bartels made a proclamation for both Mr. and Mrs. Kelley honoring their devoted years of civic service to the community. Mayor Bartels stated that Mr. and Mrs. Kelley have embodied the finest traditions of public service, giving generously their time, talents and hearts to strengthen the community they love. Their contributions have left a positive impact on the City of Latrobe.

Mayor Bartels presented the Greater Latrobe School District Student Showcase award from the fall semester to Sarah LeVan. Miss LeVan was praised by Ms. Vavick as an excellent lifeguard who goes above and beyond while working at the Latrobe Memorial Pool. Dr. Benning, principal of Greater Latrobe Senior High School, also praised Miss LeVan for being a standout student involved in student council, cross-country and a volunteer at a retirement home. Miss LeVan had interned at the Latrobe Foundation and plans to major in civil engineering at college.

Mayor Bartels announced that January 6, 2026, will be Sarah LaVan Day and presented Miss LeVan with a proclamation that honors her for outstanding achievements and for serving as inspiration to the Greater Latrobe community.
