## Chapter 109. STREETS AND SIDEWALKS

### Article III. Snow and Ice Removal

#### § 109-13. Removal from sidewalk required.

- A. It shall be the duty of each and every owner or occupier of property in the Township to remove any snow, ice or slush from the entire width of sidewalks and around all fire hydrants in front of, alongside of or adjoining their property.
- B. Whenever a sidewalk continues to the curb on a property which is on the corner of the intersection of two Township streets or alleys, the obligation of the owner of that property shall include shoveling a path, the width of the sidewalk, to the point at which the sidewalk meets the cartway of the street or alley. The snow, ice or slush which is removed from the property shall not be deposited, blown, thrown, placed or strewn on any street, avenue or roadway within the Township.
- C. The removal of the snow, ice and slush shall be completed within 24 hours after the fall of snow or other frozen precipitation shall cease. When it is impossible to remove ice from sidewalks, antiskid material shall be placed on a temporary basis. It shall be the responsibility of the owner to keep the sidewalks and fire hydrants clear in accordance with this section due to drifting, blowing, melting and refreezing, or as the result of snow removal equipment redepositing snow in the process of clearing roadways.

#### § 109-14. Violations and penalties; enforcement.

Any person, partnership, business, corporation or other entity violating the provisions of this article **may be ticketed** for violating the provisions of this article and, upon the issuance of a citation and conviction by a District Justice, shall be guilty of a summary offense and **shall pay a fine** of not less than \$25 nor more than \$600. **Each day a violation exists shall be considered a separate violation**, subject to the same fines as set forth above. It shall not be necessary to issue a separate citation for each day of violation, but one citation shall be sufficient to cover multiple days of obstructions. The Board of Supervisors hereby authorizes the Township Manager, Township Roadmaster, Assistant Township Roadmaster and Township police officers to issue citations for violations of this article.

## Chapter 127. Vehicles and Traffic

### Article IV. Snow Emergencies

#### § 127-6. Definitions.

As used in this article, the following terms shall have the meanings indicated:

**SNOW EMERGENCY**

Any time snow removal is conducted by the Township either by plowing or by the spreading of cinders, salt or antiskid materials.

#### § 127-7. Parking or obstructing roadway prohibited.

During a snow emergency as defined in this article, it shall be unlawful to park motor vehicles, boats, campers, trailers or otherwise obstruct the roadway so as to prevent snow removal to the edge of the roadway. Parking along the roadway is only permitted after a snow emergency is no longer in effect.

#### § 127-8. Violations and penalties.

Obstructions to snow removal during a snow emergency may be towed, in which case the owner of the obstruction shall be liable to pay all costs associated with towing and storage. In addition, the owner of the offending obstruction may be ticketed for violating the provisions of this article and, upon the issuance of a citation and conviction by a District Justice, shall be guilty of a summary offense and shall pay a fine of not less than \$25 nor more than \$600. Each day a violation exists shall be considered a separate violation, subject to the same fines as set forth above. It shall not be necessary to issue a separate citation for each day of violation, but one citation shall be sufficient to cover multiple days of obstructions. The Board of Supervisors hereby authorizes the Township Manager, Township Roadmaster, Assistant Township Roadmaster and Township police officers to issue citations for violations of this article.
